Section Officers Vote To Dissolve Section C6B

The Council of Chiefs meeting, held on April 3rd, will be the final function of Section C6B.

Due to the upcoming realignment of the sections within the Central Region, the 2004 Conclave which was to be held at Spanish Peaks Scout Reservation, in Colorado, in September, would have been the final Section C6B event.

Two of the six lodges did not feel they could bring an adequate number of Arrowmen to SPSR, so the Council of Chiefs voted not to hold the conclave, and to dissolve the section effective immediately.

The lodges of our new section will meet in May to elect new section officers and make plans for the future.
